Course Descriptions

CORE COURSES

NURS 500 Evolving Roles of the Advanced Practice Nurse (3 units)

This course explores the roles of advanced practice nurses in professional and organizational contexts. In the course, students will learn how to apply nursing theory and cultural competency to team-based environments. They'll also learn effective collaboration and communication skills, tailored to health care settings. With that, students will analyze key issues and challenges affecting outcomes and learn how to be an effective organizational and systems leader.

NURS 501 Ethics, Policy, and Legal Implications for Advanced Practice Nursing (3 units)

In this course, students will examine the social, political, ethical, and economic structures of nursing practice. Alongside this, they'll study the factors shaping access to safe, high-quality care in both domestic and global systems. The course also analyzes activism and advocacy in U.S. health care. Ethical reasoning is emphasized as the foundation for practice, policy, and economics, as well as for corollary laws, regulations, resource allocation, funding strategies, costs, budgeting, and outcomes.

NURS 502 Information Management for Advanced Nursing Practice (2 units)

This course provides advanced practice nursing students with an overview of the management of information and data through application of computer, information, and nursing practice concepts. The focus is on how information technology is employed within clinical practice, administration, education, and research settings to disseminate healthcare knowledge and promote interprofessional communication to optimize care delivery and outcomes. The course enhances knowledge and understanding of the ethical and legal considerations associated with application of informatics in the healthcare and education settings. Selected software programs/ applications are presented and used.

NURS 503 Science Development, Study Design, and Statistics (3 units)

The focus of this course is scholarly inquiry and translation of evidence into protocols and practice within the context of ethics, advocacy, and patient safety. Scholarly inquiry for this course includes systemic critical analysis, evaluation, synthesis, application, and integration of theoretical and empirical principles of research to generate evidence-based recommendations for nursing practice.

SCIENCE CORE COURSES

NURS 510 Pathophysiological Foundation for the Advanced Practice Nurse (3 units)

The content of this course covers concepts in human physiology and pathophysiology that serve as foundation for advanced practice nurses in their clinical assessment, clinical diagnostic decision-making, and health care management. Alterations of various physiological systems and pathophysiology of frequently encountered health conditions across the life span, including special populations, are reviewed. Evidencebased concepts relevant to normal physiology, etiology, including those relevant to genetics and environment, and clinical manifestations and responses to common diseases/altered health states are compared across life span. Clinical screening and diagnostic evaluative methods are also discussed.

NURS 511 Assessment and Diagnostic Reasoning (3 units)

This course provides the student with knowledge of advanced health assessment of clients within the context of the advanced practice role. This course builds on the knowledge of anatomy, physiology, pathology, and health assessment skills attained in previous courses. Emphasis is on acquisition and analysis of relevant data for the development of a comprehensive and holistic assessment and interpretation of screening and diagnostic tests to formulate a differential diagnosis.

NURS 511L Assessment and Diagnostic Reasoning Lab (1 unit)

The emphasis of this laboratory course is on the knowledge and application of advanced skills required to perform a comprehensive health assessment. Practice of health assessment techniques, guidelines, and consideration for patients across the life span are presented. There is a focus on normal findings within each body system and deviations relevant to age, gender, ethnicity, and diseases.

NURS 512 Pharmacological Foundation for the Advanced Practice Nursing (3 units)

This course provides the knowledge and skills for clinical application of advanced pharmacology and pharmacotherapeutics as it relates to common health conditions of the adolescent, adult and geriatric patient. Emphasis is on the development of therapeutic decision making in drug selection for the client based on health problems, individual variations, cultural and economic considerations. Focus is on the prescriptive practice, client education and monitoring of the therapeutic response to pharmacological agents in diverse clients across the lifespan.

NURSING EDUCATION COURSES

NURS 560 Theories of Teaching and Instruction in Nursing (3 units)

This course focuses on examining prominent theories of teaching and models of instruction that are applicable to the classroom, nursing skill laboratory, and clinical education. Theoretical approaches classified as behaviorist, social interactionism, and cognitive as well as adult learning theories are discussed and analyzed. Evidencebased research relative to nursing education is reviewed and critiqued.

NURS 561 Curriculum Development in Nursing (3 units)

Curriculum principles and strategies that incorporate accrediting nursing bodies curricular essentials are presented. Curricula of the associate, baccalaureate and graduate nursing degrees are addressed and differentiated with reference to accrediting bodies' curricular essentials and certifying state regulators requirements. Emphasis is placed on integrating the interplay of curricular systematic decision-making, curriculum planning and development, systematic assessment of outcomes, and accreditation requirements/self-study.

NURS 562 Evaluation and Assessment in Nursing Education (3 units)

This course explores various theories on assessments and evaluation and examines important theoretical, ethical and practical issues in assessment, evaluations, measurement and testing in nursing education.

NURS 563 Nurse Educator Role Development (3 units)

This course focuses on examining models of the nurse educator role and analyzing strategies for effective teaching, practice, scholarship, and service. Leadership is examined through the lens of a system framework for effective change and transformation.

NURS 664 Strategies in Nursing Education (3 units / practicum)

This course focuses on providing mentored training on integrating evidence-based, learning-centered teaching and learning strategies. This practicum course is completed with a nurse educator preceptor in a selected setting (classroom, skills and simulation laboratory, clinical practice). The course affords students the opportunity to refine educational expertise in their selected areas of interest (e.g. assessment of learning needs, program/curriculum planning, implementation, and assessment/evaluation in either a traditional or nontraditional setting). This practicum offers the opportunities for students to begin integrating the role of the nurse educator into their professional behaviors.

NURS 697 Directed Comprehensive Studies/Exam (1 unit)

The comprehensive final examination for students in the Master of Nursing program is designed to test the student's ability to integrate and apply knowledge from the core areas of nursing to a specialty area. The master's examination serves as a culminating activity, which provides a student with the opportunity to synthesize knowledge and experience gained through his/ her master's program. This examination forces the student to rise above individual courses to reach a comprehensive understanding of theory and principles of the nursing discipline and his/ her area of specialty; and to use the knowledge gained in individual courses as the foundation from which such comprehensive understanding is reached. The schedule of this one-unit course is composed of 5 class sessions of 3 hours each to assist and guide students' integrative learning and synthesis. Comprehensive examination must be taken after students have completed all units of study and successfully completed it before the award of a degree.

The Advantages of CSUN's Approach to Supporting the Educational Success of Working Professionals

Starting a degree program is a big step, but – for working adults – the real value is in completing the program. That is why CSUN focuses on providing the outstanding student support services that ensure participants meet their educational goals and succeed in graduating. We recognize that midcareer professionals undertaking advanced professional education need to focus on their academic work to be successful in the program. This recognition prompted the development of a level of support services rare among public universities.

Students should not have to spend time trying to figure out and navigate the university's administrative systems. With that in mind, the program coordinator assigned to each cohort works with students from the point of application through graduation. This practice ensures that each student will have direct personal support with a specific person to email or call with any questions or concerns at any time during the program. Each program coordinator is also a proactive part of the cohort experience, providing ongoing information, regular reminders and consistent encouragement.

Each degree program also has an assigned academic lead. This is a faculty member with specific responsibilities for coordinating the work of the faculty teaching in the program and responding to academic questions students may have that go beyond the scope of an individual course. Participants in each cohort know their academic lead well and can take advantage of this resource for guidance whenever they face an academic challenge.

To be admitted to the program, you must possess (at the time of enrollment):

- A baccalaureate degree in nursing from an accredited nursing program with a cumulative GPA of 3.0 or above.
- A current active U.S. RN license.
- Basic Pathophysiology or the equivalent.
- Health assessment with lab or the equivalent.

• Minimum of 1-year experience as a Registered Nurse (preferred).

An admissions team, composed of faculty and staff, may also ask you for an interview.
