

## REQUEST FOR ENROLLMENT PROTECTION

### Summer Session 2013

**What is enrollment protection?**

Full payment for Summer Session is due within two hours of registration. Enrollment protection will protect you from being automatically disenrolled from classes for non-payment.

**This form is for students who:**

1. were awarded a Pell Grant for 2012-13 and did not enroll full-time for either Fall and/or Spring semesters
2. are currently matriculated in a certificate or degree program at CSUN;
3. plan to enroll in a minimum of 6 units in Summer Session 2013; and,
4. plan to use financial aid funds to finance Summer Session 2013.

You should make a decision about staying in or dropping a class by these dates, even if you haven't yet received your financial aid award. If you do not receive financial aid to cover all, or part, of your tuition and fees, you are still responsible for the outstanding balance.

- **Fall 2013 registration begins for most CSUN students in mid-July.**
- **An outstanding summer balance may prevent you from enrolling in Fall 2013.**
